## RE: Consultation on Implementing Partial Cost Recovery charges – Launches and Returns

The Communications Alliance Satellite Services Working Group (SSWG) welcomes the opportunity to comment on the Australian Space Agencies' consultation on *Implementing Partial Cost Recovery*.

The SSWG generally supports the proposal in the Australian Space Agency's proposals for the recovery of costs by Government for work on Australian and Overseas Permits. The SSWG cautions, though, that attention should be paid to keeping costs as low as possible, lest the overall fee and tax impost of satellite systems operation becomes a barrier to entrants. While the ACMA has made some welcome progress on spectrum fees recently, overall spectrum charges in Australia are prohibitive in comparison to fees applicable in many other national markets.

The SSWG is satisfied with the fees proposed for single GSO networks. There is, however, concern with regards to the application of the fees for permits when authorisation for number of identical NGSO satellites on a single launch vehicle is being sought for a launch under a single permit. In such cases, the SSWG believes that a single fee for a single launch should be charged. This approach is reasonable since in this case the Agency is only examining a single satellite type on a single launch vehicle and the application for each of the satellites is effectively identical.

For example, the Belgian regulator (BELSPO) has granted the following licences which cover multiple satellites on a same launch vehicle:

- a licence granted to Von Karman Institute on 19 June 2014 to cover 3 satellites: <a href="http://www.belspo.be/belspo/space/objects.asp?l=en&info=auth&r1=2014">http://www.belspo.be/belspo/space/objects.asp?l=en&info=auth&r1=2014</a> &r2=01.

The fee for each application for a licence is set at €1,000 in Belgium under Article 13 of the Royal Decree implementing certain provisions of the Law of 17 September 2005 relating to

launching, flight operations or guidance of space objects, which is accessible at: <a href="http://www.belspo.be/belspo/space/doc/belaw/AR\_spatial\_fr.pdf">http://www.belspo.be/belspo/space/doc/belaw/AR\_spatial\_fr.pdf</a> .

Based on this, the SSWG supports the Agency's proposals but seeks a clarification that for launches involving identical satellites on a single launch vehicle that only the fee for a single satellite network for launch will be charged.
